In this regard, MSME-TC, Ludhiana is pleased to train students in this field and start following training programmes at our extension center, situated at G.T. Road, Nilokheri, Distt. Karnal (Haryana), as per the terms and conditions mentioned below:

- 1. Diploma in Fire & Safety Engineering
- 2. Advance Diploma in Fire & Safety Engineering

Terms & Conditions:

- Training facility pertaining to domain skill will be set up by you at CTR Extension Centre, Nilokheri, Distt. Karnal, Haryana.
- b) A general book of record of each course curriculum shall be kept under the custody of administrative office of MSME-TC Ludhiana as well as NCFSE, Zirakpur. Whenever the need arises for changes/updations, these are done in both the master copies simultaneously.
- c) The tenure of this operation will be upto 31st August, 2020 which can be extended based upon performance during this period.

Roles and Responsibilities of MSME-TC LUDHIANA:

a) The programmes would be conducted at Nilokheri in Mode 1 and Mode 2

Mode 1: Programmes would be conducted at Nilokheri.

Mode 2: Programmes would be offered to candidates having undergone 330 hours

of theory classes at your centres.

b) The required sitting arrangements for students in the Theory Class Rooms and lab would be provided.

- c) Hostel facilities for candidates shall be arranged @ ₹ XXXXXX p.m. in the premises.
- d) MSME-TC Ludhiana would have the full privilege to Intervene, Evaluate and Assess each Candidature's Academic, Practical Examinations (Internal and External) etc. at any time during the course.
- e) An on-line Certificate Verification process will be established and practiced.
- f) For practical training, the ground would be made available in good conditions to install and fix required equipment as per the curriculum.
- g) 22 Days Theory and Practical Training will be provided for students who have undergone theory classes conducted by NCFSE, making these students eligible for enrollment at Nilokheri. It will be carried out at CTR Extension Centre, Nilokheri for their skill development and assessment.
- h) The certificate to each enrolled student shall be issued within 30 days from the examination result announcement.

Roles and Responsibilities of NCFSE, Zirakpur, Punjab:

- a) NCFSE, ZIRAKPUR will impart this training at Extension Centre in Nilokheri, Distt. Karnal, Haryana.
- b) NCFSE shall appoint qualified faculty and other required manpower to provide complete and comprehensive training to each candidate enrolled.
- c) NCFSE shall provide study material, registration of candidates, Identity Cards, and other academic support to the students enrolled under this programme.

- d) NCFSE shall indulge in effective marketing strategies to mobilize maximum candidates for this project.
- e) Practical Training facility for the two training programs at CTR Extension Centre, Nilokheri, will be installed and equipped by NCFSE from its part.
- f) A placement cell shall be developed to provide quality service to each student enrolled under this project.
